Dear Interim Dean Ogamien:


Thank you for your letter dated May 12, 2016 with the attached Audited Financials (Exhibit A) and Student Survey Results (Exhibit B). After a review of the documents, there are a few items where clarification or more information is needed.

- 1.) Exhibit A – The December 31, 2015 Balance Sheet contains a line item for a bank overdraft, which amount seems unusually high. Please provide an explanation as to the reason(s).
- 2.) Exhibit B – Page four indicates that the student survey was sent to 21 enrolled students, but the number of emails sent shows 29. Please clarify the reason(s) for this discrepancy.
- 3.) Exhibit B – The total number of responses is listed as 11, but only 6 are attached. Please clarify the reason(s) for this discrepancy or provide the missing responses.
