**ORDER VACATING PRIOR ORDER
GRANTING EXTENSION OF TIME TO
PAY RESTITUTION**

On May 15, 2007, the court granted a motion brought by respondent Zakeya Leona Brookins, seeking an extension of time to pay disciplinary costs and restitution. On June 1, 2007, the Office of Probation, by Supervising Attorney Terrie Goldade, filed a motion to vacate the order granting respondent's motion on the grounds that the order granting was premature in that it was issued prior to the time within which the Office of Probation must file opposition, and that it improperly extended the restitution payment period. No opposition was filed to the motion to vacate.


The motion by the Office of Probation is well taken. The court received the response of the Office of the Chief Trial Counsel, but failed to wait for the response of the Office of Probation. Further, the November 30, 2007 date for payment of restitution is after the November 20, 2007 conclusion of respondent's probation. As such, good cause appearing therefor, the motion to vacate the May 15, 2007 order is **GRANTED.**¹

The Office of Probation is ordered to file a response forthwith indicating whether it opposes the proposed probation extension set forth in respondent's supplemental declaration, attached as Exhibit 1 to the response by the Office of Probation to the motion for extension of

time filed on May 21, 2007.


