ORDER RE ETHICS SCHOOL REPROVAL CONDITION

This matter is before the court on the May 18, 2017, request of respondent Daniel Mark Bornstein (Respondent) to confirm his satisfaction of the ethics school condition that is attached to the private reproval imposed on him in the court's September 19, 2016, decision and discipline order and order sealing certain documents herein. The Office of Chief Trial Counsel of the State Bar of California filed a statement of nonopposition to Respondent's request.

With his request, Respondent provided the court with proof that he attended a session of the State Bar Ethics School and passed the test given at the end of that session on December 3, 2015, while Respondent was participating in the ADP. Accordingly, under the express terms of the court's Confidential Statement of Alternative Dispositions dated January 26, 2015, Respondent need not attend and pass another session of ethics school.

ORDER

The court orders that respondent Daniel Mark Bornstein's May 18, 2017, request to confirm the satisfaction of his ethics school reproval condition is GRANTED. Further, the court CONFIRMS that respondent Daniel Mark Bornstein effectively complied with the ethics school



condition that is attached to the private reproval imposed on him in the court's September 19, 2016, decision and discipline order and order sealing certain documents herein by attending a session of the State Bar Ethics School and by passing the test given at the end of that session on December 3, 2015, while Respondent was participating in the ADP.
