Respondent Donald Martin Wanland, Jr., State Bar Number 122462, was convicted of:

- i. 1 violation of title 26 United States Code section 7201 (tax evasion), a felony that provides probable cause to believe it involved moral turpitude based on the record of conviction;
- ii. 24 violations of title 26 United States Code section 7206(4) (removing or concealing to avoid tax collection or assessment), felonies;¹
- iii. 3 violations of title 26 United States Code section 7203 (willful failure to file tax return), misdemeanors that may or may not involve moral turpitude.

Because respondent's convictions include felonies, it is ordered pursuant to Business and Professions Code section 6102 that respondent be suspended from the practice of law effective February 19, 2014, pending final disposition of this proceeding. (Cal. Rules of Court, rule 9.10(a).) It is further ordered that respondent comply with California Rules of Court, rule 9.20, and perform the acts specified in subdivisions (a) and (c) of that rule within 30 and 40 days, respectively, after the effective date of this suspension.

¹ The Office of Trial Counsel stated in its transmittal that it will provide certified versions of the indictment and an interim order. We are reserving the classification pending receipt of these additional certified records.



As the State Bar Court has not yet received evidence that the convictions are final, we will take no further action at this time pending the submission of additional records of conviction, evidence of finality of the convictions, or respondent's waiver of finality pursuant to rule 5.344(B) of the Rules of Procedure of the State Bar.


