On August 7 and 15, 2014, respondent Steven Anthony Guilin filed a motion and a declaration, respectively, for an extension of time to take and pass the Multistate Responsibility Examination (MPRE) and Ethics School. He had unsuccessfully attempted the MPRE and, due to financial hardship, has been unable to take it again and to attend Ethics School. He has registered for the November 2014 MPRE and for the October 23, 2014 session of Ethics School. The Office of Probation filed opposition on August 12, 2014.

The court has carefully considered the motion and response and finds good cause to extend the time as requested. Accordingly, the time within which respondent must take and pass the MPRE and provide proof of passage to the State Bar and successfully complete Ethics School and provide proof thereof to the Office of Probation is extended to January 30, 2015.


