ORDER RE RESPONDENT'S MOTION TO EXTEND TIME TO COMPLETE ETHICS SCHOOL AND MPRE EXAMINATION

On June 8, 2016, respondent Robert Daniel Rodriguez filed a motion for extension of time to complete the State Bar's Ethics School and take and pass the Multistate Professional Responsibility Examination (motion for extension). On June 16, 2016, Office of Probation Supervising Attorney Terrie Goldade filed an opposition to the motion for extension.

The court has carefully considered the motion and response and finds Respondent's motion for extension is consistent with protecting the public; the member's successful rehabilitation; and maintaining the integrity of the legal profession. (Rules Proc. of State Bar, rule 5.300(B).) Accordingly, the court issues the following orders:

(1) Good cause having been shown, Respondent's motion for extension of time to complete the State Bar's Ethics School is GRANTED. Respondent is ORDERED to provide proof of completion of the State Bar's Ethics School to the Office of Probation by August 11, 2016.



(2) Good cause having been shown, Respondent's motion to extend the time within which he must prove passage of the Multistate Professional Responsibility Examination (MPRE) to the Office of Probation is **GRANTED**. Respondent is **ORDERED** to provide proof of passage of the MPRE to the Office of Probation by **September 16, 2016**.
