ORDER

On November 15, 2017, the Office of Chief Trial Counsel of the State Bar (OCTC) submitted five records of conviction of attorney, which establish that respondent Michael Armin Gardner, State Bar Number 196079, has been convicted of violating:

- 1. Virginia Code Annotated section 18.2-67.2 (object sexual penetration upon a child), a felony involving moral turpitude (Case no. 12-C-13650);
- Virginia Code Annotated section 18.2-67.3 (aggravated sexual battery upon a child), a felony involving moral turpitude (Case no. 17-C-03050);
- 3. Virginia Code Annotated section 18.2-67.3 (aggravated sexual battery upon a child), a felony involving moral turpitude (Case no. 17-C-03053);
- 4. Virginia Code Annotated section 18.2-67.3 (aggravated sexual battery upon a child), a felony involving moral turpitude (Case no. 17-C-03055); and
- 5. Virginia Code Annotated section 18.2-67.3 (aggravated sexual battery upon a child), a felony involving moral turpitude (Case no. 17-C-03069).

Because respondent has been convicted of felonies involving moral turpitude, it is

ordered pursuant to Business and Professions Code section 6102 that respondent be suspended

from the practice of law effective January 8, 2018, pending final disposition of these proceedings. (Cal. Rules of Court, rule 9.10(a).) It is further ordered that respondent comply with California Rules of Court, rule 9.20, and perform the acts specified in subdivisions (a) and (c) of that rule within 30 and 40 days, respectively, after the effective date of this suspension.

On November 15, 2017, OCTC filed a request for summary disbarment in case numbers 17-C-03053; 17-C-03055; and 17-C-03069. This court will file separately its ruling on that motion.
