On April 18, 2014, petitioner **Young Sik Cho** sought a five-year extension of time to comply with the order assessing disciplinary costs in State Bar Court case no. 12-C-17848. (Rules Proc. of State Bar, rule 5.130(B).) Petitioner's motion was based on financial hardship. On May 1, 2014, the Office of the Chief Trial Counsel of the State Bar of California (State Bar) filed a response. The State Bar did not oppose a three-year extension of time to pay costs.

Good cause having been shown, petitioner's motion for extension of time to comply with the order to pay disciplinary costs is **GRANTED**, in part. The court orders that petitioner's time to pay the remaining disciplinary costs associated with case no. 12-C-17848 be extended and that three payments of one-third each of said costs are to be paid with petitioner's annual State Bar membership fees for the years 2015, 2016, and 2017. The court further orders that, if petitioner fails to pay any installment of disciplinary costs within the time provided herein or as may be

modified by the State Bar Court pursuant to Business and Professions Code section 6086.10, subdivision (c), the remaining balance of the costs is due and payable immediately unless relief has been granted under the Rules of Procedure of the State Bar of California (Rules Proc. of State Bar, rule 5.134). The payment of costs remains enforceable both as provided in Business and Professions Code section 6140.7 and as a money judgment.
