On December 10, 2015, respondent Anthony E. Contreras filed a request to vacate the Court's November 20, 2015 suspension order, which suspended him for failure to pass the Multistate Professional Responsibility Examination (MPRE) within the time prescribed by Supreme Court order. Respondent asserted that he passed the November 7, 2015 MPRE. On December 16, 2015, the Office of Probation of the State Bar responded stating that it does not oppose the request because respondent has provided sufficient proof of passage of the MPRE.

Respondent's request is granted. The suspension imposed by order filed November 20, 2015, is terminated, effective upon the filing of this order. (Cal. Rules of Court, rule 9.10(b).)

This order does not limit or alter a suspension order imposed against Contreras in any other discipline or regulatory matter.<sup>2</sup>
