On August 21, 2017, respondent Lori Jo Sklar (Respondent) filed a motion to modify a term of her probation in Supreme Court case No. S238847 (State Bar Court case No. 13-O-14606). Specifically, Respondent requests that this court extend the time to take and pass the MPRE until April 21, 2019, based on her current financial difficulties. On August 28, 2017, the Office of Probation of the State Bar of California (Office of Probation) filed an opposition to the motion. On September 5, 2017, Respondent filed a reply to the Office of Probation's opposition.

Respondent was ordered to take and pass the MPRE within one year of April 21, 2017, the effective date of the Supreme Court's order in case No. S238847. The requirement that Respondent must take and pass the Multistate Professional Responsibility Examination (MPRE) is not a probation condition. It is a Supreme Court order with which Respondent must comply. However, this court has the authority to extend the time within which to take and pass the MPRE. (Rules Proc. of State Bar, rule 5.161; Cal. Rules of Court, rule 9.10(b).)



GOOD CAUSE APPEARING, Respondent's motion is **GRANTED**, in part, and Respondent is hereby **ORDERED** to provide proof of passage of the MPRE to the Office of Probation on or before **December 20, 2018**.

IT IS SO ORDERED.


