On December 17, 2018, respondent Lori Jo Sklar (Respondent) filed a motion to modify the court's February 8, 2018 order extending the time for Respondent to pay disciplinary costs in State Bar case No. 13-O-14606. The court construes Respondent's motion as a motion to modify the original order assessing disciplinary costs in State Bar Court case No. 13-O-14606, Supreme Court case number S238847, as modified by the February 8, 2018 order (Rules Proc. of State Bar, rule 5.130.)

Respondent requests that the previously extended deadline for her to pay the costs that were due with her 2019 annual State Bar membership fees be further extended to 2020.

Respondent's motion is based on financial hardship. (See Rules Proc. of State Bar, rule 5.130(B).) On December 18, 2018, the Office of Chief Trial Counsel of the State Bar of California (OCTC) filed a response. In its response, OCTC did not oppose Respondent's request for an extension of time for the payment of costs.

Good cause having been shown, the court **GRANTS** an extension of time for Respondent to comply with the order to pay disciplinary costs. The court orders that Respondent's time to pay the remaining disciplinary costs associated with case No. 13-O-14606 be extended and that



one-fourth of said costs is to be paid with Respondent's annual State Bar membership fees for the years 2020, 2021, 2022, and 2023.

The court further **ORDERS** that if Respondent fails to pay any installment of disciplinary costs within the time provided herein or as may be modified by the State Bar Court pursuant to Business and Professions Code section 6086.10, subdivision (c), the remaining balance of the costs is due and payable immediately unless relief has been granted under the Rules of Procedure of the State Bar of California (Rules Proc. of State Bar, rule 5.134). The payment of costs remains enforceable both as provided in Business and Professions Code section 6140.7 and as a money judgment.
