TO ALL PARTIES AND COUNSEL IN THE ABOVE ENTITLED MATTER:

On December 12, 2016, respondent Elias Francisco Portales has requested an extension of time to pay disciplinary costs imposed by the July 29, 2016 Supreme Court order, case No. S234651, based on his financial hardship.


On December 14, 2016, Supervising Senior Trial Counsel Robert A. Henderson of the Office of the Chief Trial Counsel of the State Bar of California (State Bar) did not oppose such an extension.

In view of respondent's financial hardship, the court hereby **ORDERS** that respondent's time during which to pay the disciplinary costs in S234651 be extended and that one-fifth of the costs must be paid with his membership fees for each of the years 2017, 2018, 2019, 2020 and 2021. If Elias Francisco Portales fails to pay any installment as described above, or as may be

modified by the State Bar Court, the remaining balance is due and payable immediately. The payment of costs remains enforceable both as provided in Business and Professions Code section 6140.7 and as a money judgment.


