On October 17, 2016, respondent James Lissant Conkey (respondent) filed a motion to extend the time for him to take and pass the Multistate Professional Responsibility Examination (MPRE) in case No. 14-O-05953. Respondent plans to take the March 18, 2017 MPRE.

The Office of Probation filed a response to respondent's motion on October 20, 2016, and an amended response on October 24, 2016. The Office of Probation does not oppose an extension of time for respondent to provide proof of passage of the MPRE by April 29, 2017.<sup>1</sup>


After thorough consideration, the court finds respondent's motion for an extension of time to take and pass the MPRE is consistent with protecting the public; the member's successful rehabilitation; and maintaining the integrity of the legal profession. (Rules Proc. of State Bar, rule 5.300(B).) Accordingly, respondent's motion to extend the time to take and pass the MPRE is **GRANTED**. Respondent is **ORDERED** to provide proof of passage of the MPRE to the Office of Probation on or before **Monday, May 1, 2017**.


