On June 21, 2012, Petitioner filed a request requesting that the time during which he may once again file a petition to be re-admitted to the Bar be modified under rule 5.442 so that he may file a new petition as soon as two years have passed since the captioned petition was submitted for decision on March 8, 2012, rather than when that adverse decision was effective more than two months later. On July 6, 2012, the State Bar filed an opposition to the request.

Rule 5.442 provides, in pertinent part, that "a subsequent petition [for reinstatement] cannot be filed for two years after the effective date of the adverse decision, <u>unless a shorter period is</u> <u>ordered by the Court for good cause</u>." Good cause exists for the requested relief being granted in this case. Respondent's petition in this matter was filed on August 18, 2011. Trial was completed on March 8, 2012. The matter was then submitted for decision on that date, although the parties were given an opportunity to submit post-trial briefing. This court then delayed preparation of its decision until after those briefs were received. The decision was not filed by the court until May 31, 2012.

While this court's decision was filed well within the allowable time for it to do so, had the decision been issued at an earlier date, the two-year period under rule 5.442 would have elapsed early enough that Petitioner could have petitioned again for reinstatement during the five-year period following his passage of the California Bar examination on May 18, 2011. Given that the decision was filed and became effective just slightly after May 18, 2012, he will now be required to sit again for the bar examination before another petition may be filed, unless relief is granted under rule 5.442.

Such an onerous result was never contemplated or intended by this court, and such would be both unnecessary and unreasonable. In both of Petitioner's prior unsuccessful efforts to be readmitted to the bar, there has been no dispute that he has the requisite knowledge of the general law. Instead, he has been actively involved in working in a law firm as a part-time paralegal/law clerk for many years, and the uncontradicted evidence regarding his ongoing and present legal knowledge has been quite favorable.

GOOD CAUSE HAVING BEEN DEMONSTRATED, this court exercises its authority under rule 5.442 to shorten the time required under that rule such that Petitioner may file another petition for reinstatement on or after March 8, 2014.

IT IS SO ORDERED.


