We have received evidence that respondent Adam J. Luetto, State Bar Number 264188, has been convicted of the following:

1. Case number 15-C-10306: Penal Code sections 484, subdivision (a) - 488 (petty theft), a misdemeanor involving moral turpitude;
2. Case number 15-C-10307: Penal Code sections 484, subdivision (a) - 488 (petty theft), a misdemeanor involving moral turpitude;
3. Case number 15-C-10308: Penal Code sections 484, subdivision (a) - 488 (petty theft), a misdemeanor involving moral turpitude; and
4. Case number 15-C-13690: Penal Code section 466 (possession of burglary tools), a misdemeanor with probable cause to believe involves moral turpitude, and Vehicle Code section 23103 (reckless driving), a misdemeanor that may or may not involve moral turpitude.

Accordingly, it is ordered pursuant to Business and Professions Code section 6102 that respondent be suspended from the practice of law effective October 13, 2015, pending final disposition of this proceeding. (Cal. Rules of Court, rule 9.10(a).) It is further ordered that respondent comply with California Rules of Court, rule 9.20, and perform the acts specified in

subdivisions (a) and (c) of that rule within 30 and 40 days, respectively, after the effective date of this suspension.


