

Respondent is notified that:



If you fail to timely move to set aside your default, this Court will enter an order recommending your disbarment without further hearing or proceeding. ORDER ENROLLING INACTIVE:

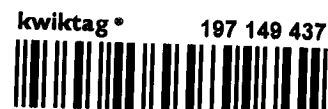


