) **ORDER RE MOTION FOR**
) **MODIFICATION OF PROBATION**

On July 26, 2018, respondent Daphne Lori Macklin filed a motion to modify a condition of her probation. Specifically, respondent requested that the probation requirement be changed to allow treatment from a Licensed Marriage and Family Therapist (LMFT) under the supervision of a psychologist instead of treatment by a licensed psychologist or psychiatrist.

On August 3, 2018, the State Bar filed an opposition to respondent's motion, noting that the motion lacked specificity as to exactly how the probation condition should be modified. However, the State Bar did not oppose the change, provided the following: that the change requires an LMFT to be under the supervision of a psychologist, and that the required reports to the Office of Probation, if submitted by an LMFT, are also signed by the supervising psychologist.


Accordingly, respondent's motion is **GRANTED** with the following modification:
On pages 20-21 of respondent's prior discipline, in paragraphs one and two under Mental Health Conditions:

1) Where "treatment from a duly licensed psychiatrist, clinical psychologist or clinical social worker" appears, "treatment from a duly licensed psychiatrist, clinical psychologist, clinical social worker, or licensed marriage and family therapist (LMFT) under the supervision of a psychologist" be inserted.

2) Where "a written statement from the treating psychiatrist, clinical psychologist or clinical social worker" appears, "a written statement from the treating psychiatrist, clinical psychologist, clinical social worker, or licensed marriage and family therapist (LMFT) (if the latter, also signed by the supervising psychologist)" be inserted.

IT IS SO ORDERED.
