On February 26, 2018, respondent Hayden Gifford Smith filed a motion for extension of time to pay disciplinary costs based on financial hardship.

On February 28, 2018, Senior Trial Counsel Erica L. M. Dennings of the Office of Chief Trial Counsel of the State Bar of California filed a non-opposition reply.

Based on respondent's financial hardship, the court hereby grants respondent's motion for an extension of time to pay disciplinary costs and **ORDERS** that respondent's time during which to pay the disciplinary costs be extended and that **one-half of the costs must be paid by May 31, 2020**, and **second one-half of the costs must be paid by May 31, 2021**. If Hayden Gifford Smith fails to pay any installment as described above, or as may be modified by the State Bar Court, the remaining balance is due and payable immediately. The payment of costs remains enforceable both as provided in Business and Professions Code section 6140.7 and as a money judgment.


