On August 17, 2018, the Court filed a Decision and Order of Involuntary Inactive Enrollment in the above-entitled matter which was served that same day on Respondent and his co-counsel Marc E. Angelucci. In light of the disbarment recommendation in the decision, the decision also included an order transferring Respondent to involuntary inactive status pursuant to Business and Professions Code section 6007, subdivision (c)(4). The inactive enrollment was effective three calendar days after the order was served by mail. Respondent's inactive enrollment therefore became effective on August 20, 2018.

However, on August 27, 2018, the copy of the Decision and Order of Involuntary Inactive Enrollment served on Respondent was returned to the State Bar Court as it was mailed with insufficient postage attached. Accordingly, as Respondent did not receive proper notice of his involuntary inactive enrollment, the court vacates the August 17, 2018 order of involuntary inactive enrollment pursuant to Business and Professions Code section 6007, subdivision (c)(4), nunc pro tunc to August 17, 2018.

The court further directs a State Bar Court court specialist to re-serve the August 17, 2018 Decision and Order of Involuntary Inactive Enrollment in the above-entitled matter on



Respondent. Respondent's involuntary inactive enrollment pursuant to Business and Professions Code section 6007, subdivision (c)(4), will therefore be effective three calendar days after the August 17, 2018 Decision and Order of Involuntary Inactive Enrollment is re-served on Respondent.
