17 Respondent responds to the Notice of Hearing on Conviction, filed on Nov. 7, 2018, as follows:

18 Respondent admits that he was admitted to the practice of law in the State of California on or
19 about January 6, 2004, and has been a member of the State Bar of California since then.

20 Respondent admits that he was convicted of a felony violation of Vehicle Code section 2800.2,
21 a felony violation of Penal Code section 69, and a misdemeanor violation of Penal Code section 148
22 (a)(1) on May 10, 2018, in Case Number 18CR00198, Superior Court, County of Santa Cruz.

23 Respondent denies that a convictions of Vehicle Code § 2800.2, Penal Code § 69, and Penal
24 Code § 148 (a)(1) are *per se* crimes of moral turpitude.

25 Respondent denies that the facts and circumstances surrounding the offenses involved moral
26 turpitude.


