On August 29, 2018, Steven Alan Weinkauf filed a resignation with charges pending. On October 24, 2018, the Office of Chief Trial Counsel of the State Bar (OCTC) filed a report and recommendation regarding Weinkauf's resignation and a Notice of No Stipulation as to Facts and Conclusions of Law. OCTC recommends that Weinkauf's resignation be rejected. Based on OCTC's reports and recommendation, and in light of the grounds set forth in California Rules of Court, rule 9.21(d), as detailed below, we recommend that the Supreme Court reject the resignation.

### I. BACKGROUND

Weinkauf was admitted to practice law in California on January 8, 1980, and has no prior record of discipline. When Weinkauf filed his resignation on August 29, 2018, there were two matters pending against him.

In the first pending matter, Weinkauf was convicted of a felony for violating Penal Code section 646.9(a), stalking, one count [with an admitted enhancement pursuant to Penal Code

section 12022(b)(1), Special Allegation – Use of Deadly Weapon], a felony which may or may not involve moral turpitude. We placed him on interim suspension (State Bar Case No. 18-C-10645), effective July 23, 2018, due to his felony conviction. On August 3, 2018, we received evidence that the conviction was final and referred the matter to the Hearing Department on August 31, 2018. In the second pending matter, on November 21, 2018, OCTC filed a Notice of Disciplinary Charges (NDC) in State Bar Court Case No. 18-O-16865. Weinkauf was charged with violating Business and Professions Code 6103 (failure to obey a court order). He has no other pending inquiry, complaint, or claim with the client security fund.

OCTC sent Weinkauf a proposed Stipulation as to Facts and Conclusions of Law
Regarding Pending Investigations, Complaints or Proceedings Against Member Who has
Submitted Resignation with Disciplinary Charges Pending (Proposed Stipulation). Weinkauf
received the Proposed Stipulation, but has refused to sign it.

# II. CONSIDERATION OF THE GROUNDS SET FORTH IN RULE 9.21(d)

We have considered Weinkauf's resignation under the grounds set forth in rule 9.21(d), and summarize the relevant information that OCTC reports for each ground:

1. Whether the preservation of testimony is complete.

Preservation of the evidence is not necessary in the pending matters.

2. Whether after transfer to inactive status, Weinkauf has practiced law or has advertised or held himself out as entitled to practice law.

OCTC has no evidence that Weinkauf has practiced law in California or held himself out as entitled to practice law in California since he submitted his resignation with charges pending on August 29, 2018.

# 3. Whether Weinkauf performed the acts specified in rule 9.20(a)-(b).

It is unknown whether or not Weinkauf performed the acts specified in rules 9.20(a)-(b), as it is unknown whether he had any clients. Weinkauf has not filed his rule 9.20(c) compliance declaration. He has not been eligible to practice law in California since July 23, 2018, pursuant to this court's order of interim suspension in his criminal conviction matter.

4. Whether Weinkauf provided proof of compliance with rule 9.20(c).

Weinkauf has not filed a rule 9.20 compliance declaration with the State Bar Court.

5. Whether the Supreme Court has filed a disbarment order.

The Supreme Court has not filed a disbarment order.

6. Whether the State Bar Court has filed a decision recommending disbarment.

The State Bar Court has not filed a decision or opinion recommending Weinkauf's disbarment.

7. Whether Weinkauf previously resigned or has been disbarred and reinstated to the practice of law.

Weinkauf has not previously resigned or been disbarred in California.

8. Whether Weinkauf entered a stipulation with OCTC as to facts and conclusions of law regarding pending disciplinary matters.

Weinkauf has refused to sign a Stipulation of Facts and Conclusions of Law regarding the pending matters detailed above.

9. Whether accepting Weinkauf's resignation will reasonably be inconsistent with the need to protect the public, the courts, or the legal profession.

We recommend rejecting Weinkauf's resignation for the reasons OCTC presented in its filings in this matter. Weinkauf was convicted of violating Penal Code section 646.9(a), stalking, with an admitted enhancement – Use of a Deadly Weapon, and has an additional

pending disciplinary matter. He has failed to submit his rule 9.20 compliance declaration, and has refused to enter into a stipulation as to his misconduct. Under these circumstances, we find that Weinkauf should not be allowed the benefit of resigning because it would undermine public confidence in the disciplinary system and the legal profession.

## III. RECOMMENDATION

We recommend that the Supreme Court decline to accept the resignation of Steven Alan Weinkauf, State Bar number 91421.
