On May 24, 2019, the Office of Chief Trial Counsel of the State Bar (OCTC) submitted evidence that respondent Joseph Arshawsky, State Bar Number 135891, has been convicted of violating Minnesota Statute section 609.713(2) (terroristic threats—bomb threat), a felony which may or may not involve moral turpitude. OCTC also provided evidence that the conviction is final. Respondent did not submit a response.

We acknowledge receipt of all documents and order that due to the felony conviction, pursuant to Business and Professions Code section 6102, respondent be suspended from the practice of law effective July 29, 2019, pending final disposition of this proceeding. (Cal. Rules of Court, rule 9.10(a).) It is also ordered that respondent comply with California Rules of Court, rule 9.20, and perform the acts specified in subdivisions (a) and (c) of that rule within 30 and 40 days, respectively, after the effective date of this suspension.

As the judgment of conviction is final, this case is referred to the Hearing Department for a hearing and decision as to whether the facts and circumstances surrounding the violation of which respondent was convicted involved moral turpitude or other misconduct warranting discipline, and if so found, the discipline to be imposed.
