On May 23, 2016, respondent Matthew Paul Krupnick (Respondent) was transferred to involuntary inactive status pursuant to Business and Professions Code section 6007, subdivision (b)(1). On January 16, 2019, Respondent's attorney, Alan B. Gordon (Gordon), filed a Stipulation for Transfer to Active Enrollment whereby Respondent and the Office of Chief Trial Counsel (OCTC) stipulated to Respondent's transfer to active status. (Rules Proc. of State Bar, rule 5.207.) The stipulation, which was signed by Respondent, OCTC, and Gordon, included the following statements:

- (1) the condition that was the basis for the transfer to inactive enrollment no longer exists;
- (2) Respondent is now able to practice law competently and without danger to the interests of the member's clients or to the public; and
- (3) Respondent understands that he will not be able to practice law until the Court approves this stipulation.

Having complied with the requirements of Rules of Procedure of the State Bar, rule 5.207, the court orders Respondent transferred to active status upon satisfaction of the following conditions:

- 1. Respondent has paid all required State Bar fees and previously assessed costs (Bus. & Prof. Code, §§ 6086.10 and 6140.7); and
- 2. Respondent has fully complied with any other requirements for his return to active membership status and is otherwise entitled to practice law. (Rules Proc. of State Bar, rule 5.210.)
